In today's world, information stands as one of the most valuable resources, yet it remains highly susceptible to threats and risks associated with money laundering.

E-commerce and internet-based payment systems development has undoubtedly simplified the lives of users. However, it has also opened the door for criminals to commit economic crimes, including money laundering, through network technologies.

Computer Science & Engineering includes the study and design of next-generation computing devices, systems, and computer networks. This includes computing complexes and communication systems, distributed systems for information collection and processing, as well as methods and means for IT services and service management. Understanding of information systems helps uncover money laundering.

The history of the University dates back to 1918 when Taurida University, the first higher education institution in Crimea, was established.



Today, the Crimean Federal University is the 10th and youngest federal university in Russia, founded in 2014 following Crimea's reunification with the Russian Federation. It unites major educational institutions on the peninsula.



# INTERNATIONAL TRAINING AND METHODOLOGY CENTRE FOR FINANCIAL MONITORING



The International Training and Methodology Centre for Financial Monitoring (ITMCFM) was established in December 2005 by the order of the Government of the Russian Federation.

ITMCFM was organized by Russia's financial intelligence unit – the Federal Financial Monitoring Service (Rosfinmonitoring.)

ITMCFM is a leading international AML/CFT training and methodology center for countries from all key regions of the world, including Europe, Central and Latin America, Africa, Middle East, South-East Asia. It also coordinates the activities of the International Network AML/CFT Institute. Since 2023, ITMCFM has been coordinating the International Financial Security Olympiad organized by the Ministry of Science and Higher Education of the Russian Federation, the Ministry of Education of the Russian Federation, and the Federal Financial Monitoring Service in accordance with Russian President Vladimir Putin's mandate.



The Centre provides information, expert, and methodology assistance to Russia's partner states, trains staff of organizations - participants of the national AML system, translates FATF and FATF-style regional bodies' policy documents, publishes research papers, manuals, and Rosfinmonitoring's *Financial Security* periodical journal.

Every year, ITMCFM organizes more than 100 events for participants in the AML systems of Russia and partner countries with almost 1.5 thousand AML/CFT specialists undergoing professional training.



## Centre's activities for International Anti-Money Laundering Systems encompass:

- Participation of the Center's experts in working group meetings and FATF-style regional bodies' plenary meetings as members of the delegation of the Russian Federation.
- Facilitating Russia's membership in the Council of Heads of Financial Intelligence Units of the CIS Member States.
- Holding international events: consulting private sector of Eurasian states, meetings and forums with Russia's AML/CFT partners, joint workshops with EAG, CIS CH FIUs, CIS Anti-Terrorism Center, and more.
- Ensuring maximum outreach to an international audience of trainees through a distributed videoconferencing network.

## Centre's educational activities for the Russian national AML system:

- Teaching law enforcement officers involved in AML/CFT work.
- Training employees of supervisory bodies involved in AML/CFT work.

#### Centre's research activities:

- Implementing research and analytical studies to improve Russia and partner states' compliance with the international AML/CFT standards.





FIAN's roots date back to the same era as the establishment of the Russian Academy of Sciences, a time when physics attained rightful recognition as an independent scientific field in Russia. Its origins trace to the early 18th century when it evolved from the Physical Cabinet of the Academy

of Sciences, an institution founded by Peter the Great.

The contemporary history of FIAN is closely linked to the renowned optical physicist Sergey Vavilov, who founded the institute in 1934. Within FIAN, six major scientific departments conduct research in key areas of modern physics, encompassing quantum physics, optics, nuclear physics, solid-state physics, theoretical physics, and astrophysics. FIAN has branches in

Troitsk, Samara, Protvino, Alma-Ata, Pushchino Observatory, and Pamir Observatory.

The collaboration between FIAN and the Federal Financial Monitoring Service (FFMS) has generated prototype of the Transparent Blockchain system, designed for the analysis and monitoring of cryptocurrency asset flows. This collaboration has facilitated pilot AML/CFT investigations carried out by FFMS analysts and law enforcement agencies, leading to the resolution of high-profile criminal cases, including drug trafficking on Hydra, one of the largest underground marketplaces.

The system prototype underwent real-world testing, proving its adequecy and effectiveness. Transparent Blockchain is currently under further development to serve as an analytical foundation for anti-money laundering systems throughout the Eurasian region.



In order to equip future AML/CFT specialists with diverse information analysis approaches and practical skills for financial investigations, the Lebedev Physical Institute has developed the Graphus training system in response to a request from the International Training and Methodology Center for Financial Monitoring (ITMCFM). This system aims to enhance the competence of specialists in the field and introduce innovative training methodologies for conducting financial investigations.

FIAN places significant emphasis on training emerging academic talents. In April 2023, during its 18th meeting, the INI Council announced the establishment of the Inter Olympiad Training Center for Schoolchildren

and Students as a new structural unit within the Lebedev Physical Institute, under the leadership of Professor Vladimir Glotov. The Center's mission is to organize a continuous educational process that increases financial security knowledge among Russian schoolchildren and students.

The key objectives of the FIAN Inter Olympiad Training Center for Schoolchildren and Students encompass:

- Providing methodological support for the International Financial Security Olympiad;
- Enhancing the qualifications of teachers engaged in the educational process;

- Organizing and conducting workshops, training sessions, youth gatherings, and other events that contribute to the development of the Olympiad movement;


